

Pocosin Innovative Charter Board of Directors Monthly Meeting January 17, 2023

Chairman Stephanie Phelps called to order at 6:00 pm on January 17, 2023 a monthly meeting of the Pocosin Innovative Charter Board of Directors.

Approval of Agenda

Director's Report

Amelia Gouillon and Jackie Etheridge presented the Director's Report, and the current enrollment is at 230 students. Our open enrollment period began January 1. Applications will be housed in the SchoolMint system. Current applications (65):

Intent letters will be sent home to families on January 27, 2023. These forms are due on February 3, 2023 and will help determine the number of available seats for the 2023-2024 school year. Middle school students will begin new electives on January 23. Options include chorus, art, personal fitness, animal science, agriculture STEM, and local industries (see below for description of each). The second round of benchmark testing will take place January 24 through 26. We need services from a school psychologist for the 2023-2024 school year. We continue to seek out additional substitute teachers and substitute bus drivers. The second round of teacher observations began on January 17 and will continue through the end of the month. We have had three major offenses recorded in Educator's Handbook since the last Board meeting. A report of offenses can be found below. Prospective Family Open House will be January 26 and February 2 from 6-7 PM. National School Choice Week- We will be celebrating National School Choice Week on January 23-27 with a school spirit week. Ag Expo- We have started the planning process with the team. The event will take place on March 23 from 4-7 and will coincide with National Ag Week. We are looking to expand our vendor list from last year. Music and Arts Week- Mrs. Broome and Mrs. Maready have been working together to plan Music and Arts Week for the school. This will take place on April 24-28. Activities include: A K-5 and middle cahool accombling to hoov the Marry Dand a poster contact artirovily on display and the anxing

school assembles to hear the Navy Bahu, a poster contest, artwork on display, and the spring concert (April 27 @ 6:30). We have developed a new safety team to ensure all staff are trained and prepared for any unexpected event. Krista and I have scheduled weekly meetings to ensure all technology requests and services are being met. We have contacted SoundSide due to slower internet connections in the modular. We have scheduled service for them to come on Friday, January 20, 2023. We are continuing our bi-weekly meetings and on track with all deadlines for the NC Access Grant. Bus #66 has been fixed so we are able to resume our 4 bus schedule. The transportation grant offered through OCS was submitted on December 27, 2022. (*This grant will reimburse the school for up to 65% of qualifying transportation expenses made between July 2022 and December 2022*. If awarded, grants will be disbursed by February 15, 2023.)
